

UCSF May Submit 2 Applications

WHAT: The Greenwall Foundation Faculty Scholars Program (<http://www.greenwall.org/how-to-apply.php>)

PURPOSE:

- The Faculty Scholars Program is a career development program that enables junior faculty members to carry out innovative bioethics research.

ELIGIBILITY:

- Junior faculty members holding at least a 60% appointment in a tenure series
 - Priority will be given to applicants who have not yet been considered for tenure, who have not received a comparable career development award, and whose work will have an impact on public policy, biomedical research, or clinical practice.
 - Within this group, priority will be given to applicants whose research addresses innovative and emerging topics.
 - Lower priority will be given to applicants who are primarily carrying out institutional change, educational reform, or theoretical bioethics research.

BUDGET AND PROJECT PERIOD:

- Award Budget: supports 50% of a Scholar's salary plus benefits for three years, up to the NIH cap, with 10% institutional costs for the salary and benefits.
 - \$5000 provided each year for limited project support and travel (no indirect costs are provided for these items).
 - UCSF indirect cost policy will apply except for non-federal entities.
- Project Period: 3 years

 - b. How the research will be carried out and how it is likely to have an impact on public policy or clinical practice
 - c. A personal statement describing the applicant's goals in the field of bioethics
