PURPOSE:

- The purpose of the Pediatric Pulmonary Centers (PPC) program is to provide interdisciplinary training to improve the health of infants, children, and adolescents with chronic respiratory conditions, sleep issues, and other related special health care needs.
- The PPCs strive to improve systems of care and increase access to pediatric pulmonary care for children with complex health care needs.

ELIGIBILITY:

- HRSA recognizes only one project director. Co-project directors are not allowed.
- The project director must be a faculty member employed by the applicant organization at the time of application submission.
- The project director should be a board-certified pediatrician with subspecialty certification in pediatric pulmonology.
- The project director should have three or more years of experience in pediatric pulmonary health care and related emerging issues, and systems of care for children and youth with special health care needs (CYSHCN).
- The project director should dedicate at least 20% of their time to the PPC program grant, which may be a combination of grant and in-kind support. The 20% effort cannot be shared by two faculty members.
- Any individual(s) with the skills, knowledge, and resources necessary to carry out the proposed research as the Program Director(s)/Principal Investigator(s) (PD(s)/PI(s)) is invited to work with their organization to develop an application for support. Individuals from underrepresented racial and ethnic groups as well as individuals with disabilities are always encouraged to apply.

BUDGET AND PROJECT PERIOD:

- Award Budget: \$1,700,000
 - UCSF indirect cost policy will apply except for non-federal entities.
- Project Period: 1 year
