

UCSF May Submit 2 Applications - 1 from SOM & 1 from SON

WHAT: Macy Foundation Faculty Scholars (<https://macyfoundation.org/macy-scholars/about>)

PURPOSE:

- To identify and nurture promising educational innovators in medicine and nursing. Scholars will implement new educational innovations at their home institutions and participate in career development activities.
- Projects must address one or more of the following:
 - Advancing equity, diversity, and belonging.
 - Enhancing collaboration among health professionals, educators, and learners.
 - Prepare future health professionals to navigate and address ethical dilemmas that arise when the principles of the health professions are in conflict with barriers imposed by the health delivery system.
- The Foundation has particular interest in innovations that take place in learning environments where clinical care is delivered.

ELIGIBILITY:

- Be a benefits-eligible faculty member in a United States accredited nursing school, allopathic medical school, or osteopathic medical school. Candidates should have approximately three to eight years of faculty experience at the time of application.
- Be a doctorally prepared faculty member in good standing at the sponsoring school.
- Be nominated by the dean of the nursing or medical school. There can be only one nominee per nursing or medical school, and a nursing or medical school with a first-year Macy Faculty Scholar is precluded from nominating a candidate.
- Have an educational scholarship project with the appropriate institutional support.
- Have a faculty mentor who will advise the candidate on the candidate's educational project and career development.
- Have an institutional commitment for the protection of 50% of the candidate's time.
- Be a citizen or permanent resident of the United States or its territories.

BUDGET AND PROJECT PERIOD:

- Award Budget: up to \$100,000 per year, plus an additional \$25,000 per year for project support and professional development activities.
 - Scholars will also receive funding to participate in a Harvard Macy Institute course, for travel to the Macy Faculty Scholars Annual Meeting, and for other program-related travel.
 - UCSF indirect cost policy will apply except for non-federal entities.
- Project Period: 2 years
