WHAT: NSF Major Research Instrumentation Program (MRI): Instrument Acquisition or Development (https://www.nsf.gov/pubs/2018/nsf18513/nsf18513.htm)

PURPOSE:

- To increase access to multi-user scientific and engineering instrumentation for research and research training in our Nation's institutions of higher education and not-for-profit scientific/engineering research organizations
- An MRI award supports the acquisition or development of a multi-user research instrument that is, in general, too costly and/or not appropriate for support through other NSF programs

ELIGIBILITY:

The MRI Program especially seeks broad representation of PIs in its award portfolio, including
women, underrepresented minorities and persons with disabilities. Since demographic diversity
may be greater among early-career researchers the MRI program also encourages proposals
with early-career PIs and proposals that benefit early-career researchers

BUDGET AND PROJECT PERIOD:

- Award Budget:
 - Track 1: Track 1 MRI proposals are those that request funds from NSF greater than or equal to \$100,000 and less than \$1,000,000.
 - Track 2: Track 2 MRI proposals are those that request funds from NSF greater than or equal to \$1,000,000 up to and including \$4,000,000.
 - UCSF indirect cost policy will apply except for non-federal entities.

NUMBER OF APPLICATIONS UCSF MAY SUBMIT: up to two applications for Track 1; up to one application for Track 2

DUE DATES:

- Internal: 11:59 PM, Wednesday, August 10, 2022. If more than 2 LOIs are received for Track 1, or more than 1 LOI for Track 2, an additional pre-application will be due Wednesday, August 31.
- PIs submit directly to the LSP; RMS does not get involved unless and until you are nominated.
- Sponsor Submission Window: January 1 January 19, 2023.

To qualify for UCSF Limited Submission Program opportunities, applicants must have a paid UCSF appointment either at the time of application or anticipated by the time of award.

The LSP is a selection process, not an award process. As the LSP is under significant time constraints, all reviewer feedback is optional. We encourage you to seek other avenues for proposal feedback.
